**January 4, 2023**

The regular meeting of the Board of County Commissioners was brought to order at 5:30 p.m. by Vice-Chairman Jim Milne. Those in attendance were Commissioner Peter Nicolaysen, Commissioners Dave North, Commissioner Dall Laird, Commissioner Steven Freel, County Attorney Eric Nelson, and Michelle Maines, Commissioners' Assistant.

Vice-Chairman Milne opened the floor for nominations for the election of Chairman and Vice-Chairman. Commissioner Laird nominated Commissioner Freel for Chairman and Commissioner North seconded. Motion carried. Commissioner Laird nominated Commissioner North for Vice-Chairman. Commissioner Freel seconded the motion. Motion carried.

**Consent Agenda:**

Commissioner North moved for approval of the Consent Agenda as presented. Commissioner Laird seconded the motion. Motion carried.

**Public Hearings:**

A. **ZC22-3 - A** request by Brandi Forgey and Scotty Legerski for a Zone Change from the Urban Agriculture (UA) zoning district to Light Industrial (LI) zoning district. The property is located off of Commerce Drive, 40 acres in the PTN/@Section 28, Township34 North, Range 80 West of the 6th Principal Meridian, Natrona County, Wyoming. The property is currently not addressed.

The proposed location of the crusher is on 6.20 acres Lot 1 of the Shenandoah Simple Subdivision in Section 34, Township 34 North, Range 80 West of the 6th Principal Meridian, Natrona County Wyoming. The property is addressed as 6708 Zero Road.
