

**BOARD OF COUNTY COMMISSIONERS
MINUTES OF PROCEEDINGS
May 2, 2023**

The regular meeting of the Board of County Commissioners was brought to order at 5:30 p.m. by Chairman Steven Freel. Consent Agenda:

Commissioner Nicolaysen moved for approval of the Consent Agenda omitting Resolution 11-23 for further discussion. Commissioner North seconded the motion. Motion carried.

RETAIL LIQUOR LICENSES:

A. APPLICATION FOR NEW RETAIL LIQUOR LICENSE *(tabled at the 4-18-2023 BOCC meeting until the 5-2-2023 BOCC meeting)*

Commissioner North moved to remove from the table the application for liquor license that was tabled at the 4-18-2023 BOCC Meeting. Commissioner Milne seconded the motion. Motion carried.

Commissioner Laird moved to amend the motion to approve liquor license to include the following stipulations. MacMillans have already agreed to sign a notarize affidavit subject to the following conditions. Commissioner North seconded the motion.

Restrictions:

1. The liquor license can never become a part of a sexually oriented business (strip club or gentleman's club).
2. Sonny Pilcher cannot have any affiliation with the business finances, operations, property or anything else during their ownership of the liquor license.
3. Clothing is as described: referee shirts, booty shorts or miniskirts.
